B. PLANNING AND ZONING:

- Motion by Meier to approve 7/8/24 IUP without conditions for Steve & Andrea Safratowich after they sign and is checked by Ruppe, seconded Mikus and passed unanimously.
- Mobile Homes by Steve Safratowich has been licensed before zoning. But does not include manufactured homes or RV's. A letter to be sent by Oleson, and also, check with MN Department of Health.

- Lindemann/Colburn Meier moved that Ruppe write up a draft to serve Lindemann and will file with court if not heard from immediately seconded by Mikus and passed unanimously.
- Vaadeland 8:07 p.m. called Attorney Ruppe about questions on IUP. Oleson Will send a letter letting Vaadeland know that Planning Commission will do a site visit and will want to look in existing home.
- 6. Far Portage Itasca Mantrap replacing overhead line with underground crossing 22 times. Motion by Mikus that fee will be \$350.00 for miles plus \$100.00 times 22 crossing equals \$2200.00, motion seconded by Meier and passed unanimously. Motion by Schauer request \$10,000.00 Bond, also, seconded by Meier and passed unanimously.
- 7. Motion by Schauer thy if a resident has started bldg. without a permit, zoning administrator will impose 3 times the fee and if resident wants to repeal must come to board meeting, seconded by Mikus and passed unanimously.
- 8. Land Use Ordinance Motion by Meier to approve amendments to Todd Township Land Use Zoning Ordinance #2020.002 as presented with the following changes:
 - 1. That the language in Section 7.29.02 be written to allow the Town Board

to approve, at their discretion, more than two cargo containers, cargo containers larger than 400 sq. ft, cargo containers in the front yard of lots and cargo containers without screening on a case-by-case basis.

2. That language be modified as needed to ensure that semi-trailers are not allowed for storage in any zoning district;

Motion was seconded by Mikus and passed unanimously.

9. Motion by Mikus to approve Summary of the Land Use Ordinance Amendments for Publication in the township official newspaper, seconded by Meier and passed unanimously.
